# BYLAW CHANGES

## ~~C. Service Vice-President:~~

- ~~— 1. Shall be responsible for the recommendation, coordination, staffing, evaluation of all service projects, and assume any additional duties assigned by the President and the Executive Board.
  - ~~— i. Shall coordinate at least two (2) major service events per month.~~~~
- ~~— 2. Shall appoint project heads, as deemed desirable or necessary, for all projects sponsored by the Nu Rho Chapter of Alpha Phi Omega. Project heads shall be approved by a majority vote of the Executive Board.~~
- ~~— 3. Shall be the contact for other service organizations and encourage service involvement.~~

## C. Service VP

1. Shall be responsible for the coordination of all Nu Rho sponsored service projects, and the appointment of project heads and coordinators.
2. Shall be responsible for overseeing Campus Escort, and maintaining communication between the Executive Board and Escort Project Heads.
3. Shall be responsible for presenting service opportunities to the brotherhood.
4. Shall be responsible for service initiatives and issue education, such as Service Spotlights and Heart of Service.
5. Shall assume any additional duties assigned by the Executive Board.

- ~~1. Shall be responsible for the recommendation, coordination, staffing, evaluation of all service projects, and assume any additional duties assigned by the President and the Executive Board.~~

- ~~2. Shall appoint project heads, as deemed desirable or necessary, for all projects sponsored by the Nu Rho Chapter of Alpha Phi Omega. Project heads shall be approved by a majority vote of the Executive Board.~~
- ~~3. Shall be the contact for other service organizations and encourage service involvement.~~

## D. Philanthropy VP

1. Shall be responsible for providing eight (8) philanthropy events per semester.
  - i. Preferably, there should be two (2) philanthropies per month.
  - ii. One Fall semester philanthropy shall be the National Service Week project, as outlined by the Alpha Phi Omega National Office.
  - iii. One Spring semester philanthropy shall be the Spring Youth Service Day event, as outlined by the Alpha Phi Omega National Office.
2. Shall be responsible for submitting national reports for National Service Week and Spring Youth Service Day.
3. Shall be responsible for other philanthropy events, as deemed necessary by the executive board.
4. Shall be responsible for the selection and maintenance of service trips, including but not limited to Spring Break
5. Shall assume any additional duties assigned by the Executive Board

- ~~— 1. Shall be responsible for the Rush, Pledge, and Retention programs of the chapter as outlined in the National Alpha Phi Omega manuals, including registration of pledges and active members with the National Office, and shall assume any additional duties assigned by the President and the Executive Board.~~
- ~~— 2. Shall coordinate inter-family, pledge class, and retention socials to retain membership in Nu Rho~~

## E. VP Membership

1. Shall be responsible for the coordination of interfamily and pledge class events
2. Shall oversee the structure and continuation of the family system, including the facilitation and maintenance of communication among matriarchs and patriarchs, and are responsible for addressing problems with the membership structure.
3. Shall serve as an adviser for general brotherhood and will address any concerns brought forth by brothers
4. Shall coordinate retention matters within the brotherhood
5. Shall assume any additional duties assigned by the Executive Board.
